REMINDER: TIME SHEETS

We have been experiencing problems with the quality of the time sheets submitted electronically. Majority of them came out blurred and with background like carpet, tiles, and tables. Those time sheets will no longer be accepted.

For those who have iPhones and Android, we want you to download the application GENIUS SCAN in your phone and use that app in taking pictures of your time sheets. Once you are down, go to ENHANCE and choose BLACK AND WHITE. Then click EDIT and CROP the images so that the unnecessary backgrounds will not be included. Then you SAVE and EMAIL the time sheets to: dtr1stchoice@gmail.com.

You need to mail to our office the ORIGINAL time sheets of MySolutions so that you can get paid. This goes to ALL live-in and hourly caregivers. There are some working days in the past that we could not get paid for because your original time sheets were not submitted, only the blurred ones that you emailed to us.
